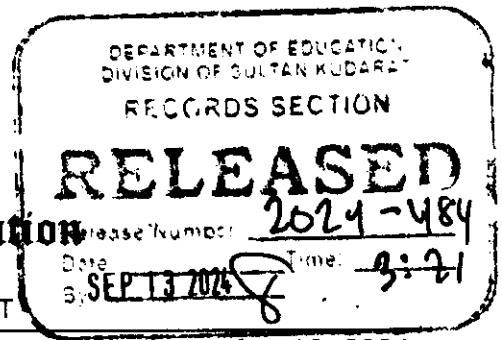

**ADMINISTRATION OF THE RAPID MATH ASSESSMENT
AND COMPREHENSIVE LITERACY ASSESSMENT FOR GRADES 1 TO 3
FOR THE BEGINNING OF THE SCHOOL YEAR 2024-2025**

1. With reference to the Department of Education (DepEd) Memorandum DM-CT-2024-284 re: **Administration of the Rapid Math Assessment (RMA)** and **Comprehensive Rapid Literacy Assessment (CRLA)** for Grades 1 to 3, this Office mandates all public elementary and integrated schools to administer the said assessments for the Beginning of the School Year (BOSY) 2024-2025 from **August 20 to September 20, 2024**.

2. The results of these assessments shall:
- be the basis for determining mathematical and reading profiles of learners in Grades 1 to 3;
 - be an invaluable tool for identifying grade readiness and skills requiring improvement in mathematical and reading skills;
 - help teachers in designing intervention activities for this school year; and
 - enable the department to champion educational equity by assessing learner performance across all schools and targeted support where it is most needed.

3. Teachers shall record the assessment results in the scoresheets provided. School heads shall ensure that the school summaries are promptly uploaded to the submission links provided below as soon as all learners are assessed not later than **September 20, 2024**.
